Dear Fellow "Mindbenders,"

As you can see, we have decided to mail you one more free issue of our newsletter. We felt that everyone should know what happened during our second official reunion held in the Ft. Bragg/Fayetteville, NC area. We also felt that for whatever reason, some just haven't found the time to join our membership. For you who have not yet joined, we have decided to make one final attempt at gaining your respect and friendship.

In the past, I have tried to maintain an upbeat manner, much like a coach cheering his/her team onward. But in this report, I am going to lay it all on the line. Last year in Denver, 26 veterans met for our first reunion, which I have no doubt was thoroughly enjoyed. It was not "military," it was not "stuffy," and it was not "controversial." It was 26 vets having a good time. This year's reunion was exactly like last year's, except we had only 17 vets, and we did break even financially more by strange luck than anything else. Like Denver, this reunion was a good time.

We arrived in Fayetteville to the sound of marching troops being deployed overseas. For many of us, the sound was all too familiar. Our hoped-for numbers for the reunion were diminished greatly by the world situation, as many soldiers of the 4th PSYOP Group (Airborne) awaited orders. The briefings by the 4th Group and by the Kennedy Special Warfare Center were excellent beyond our expectations. It is good to know that PSYOP's is now properly appreciated and is properly equipped for their missions.

The hotel staff helped us by allowing us to reduce our banquet reservations numbers by half with only a week to go prior to the dinner. The entire staff of the hotel was helpful and courteous, and their facilities were excellent.

We now have 54 full members from a roster of over 200. We have \$1200 in the bank to support some of our locator and newsletter activities. Money is not the issue, however. You, the 4th PSYOP Group soldier and veteran, are the entire reason this organization exists.
